The FDC Test is open to all dogs at least 9 months of age on the test day and must be individually registered with the AKC, recorded in the FSS program, have PAL numbers or be enrolled in the AKC Canine Partners Program.

Limited Entry: Limited entries of 15 dogs per test. Closing date: 12 noon March 1 2020. Day of test entries will be accepted if limit of 15 dogs has not been reached. Pre-entries open January 1, 2020 and will be accepted until the numerical limit is reached. If the limit is reached, a waiting list will be formed.

Testing will be held both under cover and outdoors at a working barn with horses and goats on the premises. Dogs are to remain on leash at all times. Please do not visit the test site prior to the test. No bitches in season.
