Limited Entry: Limited entries of 10 dogs per test. Closing date: 12 noon April 15, 2020. Day of test entries will be accepted if limit of 10 dogs has not been reached.

Testing will be held both outdoors at a working barn with horses on the premises. Dogs are to remain on leash at all times. Please do not visit the test site prior to the test. No bitches in season.
